# **1. Introduction**

# 2. Subscription and Payment Terms

#### • Subscription Model:

- Failed Payments:
  - If a payment fails, the system will automatically **rebill every 2 days** until the charge is successfully completed.
  - After **two consecutive failed payment attempts**, your child will not be permitted to attend practice until payment is successfully processed.

### • Cancellation Policy:

- To cancel your subscription, you must provide written notice before your next billing date.
- Cancellations made after the billing date will result in continued service for the current month, and auto-pay will continue until written notice is received.

### • No Refund Policy:

- No refunds will be issued under any circumstances.
- Credits may be offered on a **case-by-case basis** for extenuating circumstances, but this is at the sole discretion of Level Up Basketball.
- Missed practices, games, or sessions do not qualify for a refund or credit.

# 3. Parent Code of Conduct
